# University Driver Safety Requirements

We all know the importance of Safe Driving on our roads today. Attributing causes to accidents include (most commonly) Distracted Driving, Risky Driving Habits and understanding Road & Vehicle Safety.

To help keep our drivers safe, the University has a <u>University Driver Safety Program Policy</u>, which is enforced by the Office of Risk Management and the Louisiana Office of State Purchasing and Travel. UL Lafayette employees are expected to abide by these regulations, which address driver safety, control the use of vehicles on State business, reduce the State's exposure to liability, reduce loss expenses due to accidents, and achieve accountability.

Anyone driving on University Business in a state, personal, or rented vehicle is required to take the <u>"ORM Defensive Driving Online Course"</u>. This course is only accessible in the Cornerstone Training Platform. <u>Defensive Driving Training must be renewed every 3 years</u>. Because training is not applicable to everyone on campus and taken only if driving is part of your job duties, it is not assigned to all employees and taken only if applicable.

Attached is a directional sheet with instructions on how to complete this class correctly and without issue.

Notes to remember:

UNIVERSIT

- 1. If you posses an <u>out of state</u> drivers license, you must provide a copy of your driver history to the Safety Office (email: <u>safety@louisiana.edu</u>) after completing the course.
- 2. Any issues with your Official Driving History Report will be reported back to you and you will need to correct these issues with the Department of Motor Vehicles, for approval.
- 3. Following policy, high-risk drivers will not be permitted to drive on official University business.
- Undergraduate students (excluding Student labor) must have special permission to drive for University business, following the <u>Standard Operating Procedure</u>, and must request access to Cornerstone Training platform by completing the <u>UL Lafayette Temporary</u> <u>Account Application</u>.
- 5. Travel requests which include ground transportation will not be processed without an active (current) training completion in Cornerstone.
- 6. Once Defensive Driving Training is completed, please allow 72 hours for all systems to completely update (Cornerstone-Banner-ChromeRiver).


